Community Cash

In partnership with the Consumer's Energy "Our Town" dollar-for-dollar match program, we've infused over \$30,000 in to the hands of consumers to spend at local businesses this year with Community Cash Gift Certificates!

Community Day Showcase

The Chamber partnered with the School of Missionary Aviation Technology in June to offer local businesses and organizations the opportunity to exhibit their products and services at the school's "Community Day" event. This annual event hosts a 5k race, airplane fly-in, pancake breakfast, kid zone, airplane rides and more. Our vendors made the best of a somewhat stormy day and successfully connected with each other and new audiences. The committee has discussed a few modifications for next year, but overall felt that the showcase has great potential to grow.

Golf Classic

The Annual Golf Classic was held at Candlestone Golf Resort with over 140 golfers and volunteers. Golfers enjoyed a sunny day of golf with carts, coffee and pastries, dinner, 50/50, free swag, raffles and TONS of prizes. The weather was in the nineties... the warmest in many years, maybe ever! In addition, there were numerous on-course contests including a putting contest to win a Blackstone Grill! On hole #17, golfers could donate between \$1-\$20 for a 'free drive' by Mercantile Bank and purchase lunch on the turn from Walker, Fluke and Sheldon; each of these activities raised an additional \$500 for the Chamber! Over 125 attendees joined the Chamber staff and volunteer leaders for a celebration of our Members in August. Ionia Chamber Members attended an After-Hours networking event with the Greenville and Belding Area Chambers of Commerce for a new type of experience in Ionia and Montcalm County.
